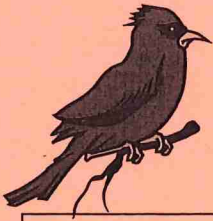

Should the request be approved, I understand and agree:

- That the request will be **valid for one year only and must be renewed annually no later than May 1st**; • That I will notify the school of any changes regarding the information on this application; • That I am willing to abide by the conditions of the Island Union Elementary School Charter; • That IUESD may revoke the Interdistrict Transfer if my child fails to maintain appropriate behavior or attendance (includes tardies);
- That my child's Interdistrict Transfer could be revoked if class sizes or programs become impacted;

Pursuant to the provisions of Board Policy 5117, my child has been granted the privilege to attend school in the Island Union School District, by virtue of an agreement between your home school district and Island Union School District. I agree that my student attend Island Union School **only under the following conditions**:

- 1) The student does not engage in any student misconduct, including, but not limited to, the violation of the law, school rule or school directives, whether or not such misconduct constitutes a violation of Education Code section 48900, et seq.;
- 2) a. The student maintains a satisfactory record of attendance, including timely attendance which means that a student must be present 90% of the school year or 7 days out of 70. Attendance under 90% will be an automatic revocation of this Charter Agreement.
  - b. Truancy per the California Education Code §48260 (see CA Ed. Code for definition). Habitual truancy (7 or more) is an automatic revocation of this charter agreement.
  - c. Tardy is defined as the student not being in their assigned seat when the bell rings for the beginning of school, 8:00 A.M. **Students who have seven (7) or more unexcused tardies will have their charter request revoked.**
- 3) The student maintains a 2.0 gpa in all classes.
- 4) I understand and agree that it is my responsibility to provide transportation for my child to and from school. I understand and agree that my child is to be **picked up from school following dismissal from class no later than fifteen (15) minutes after dismissal unless under the direct supervision of a teacher for a specified reason (athletics and etc.)**.
- 5) If a parent or student violates any of the agreed upon conditions above, the following steps will be taken
  - Written Warning
  - Hearing
    - A. Student/parent may be placed on a contract
    - B. Student/ parent will be given 5 days to enroll in their district of residency or another charter school.

\*\*\*If a major student/parent violation occurs, as determined by the site administrator, an automatic hearing will take place. A hearing will take place immediately if a student has committed an expellable offense or been suspended for five total days.

I understand and agree that I provided certain information to the District to aid in its evaluation of my charter agreement and that I did so voluntarily after providing my express consent.

I understand and agree that I must renew my charter agreement annually. **I understand and agree that the failure of me or my student to abide by and follow these conditions on a daily basis may result in the unilateral revocation of the charter agreement and the necessity of my child attending school in our district of residence.**
