- 8. Teacher training. Trainings will be provided to teachers, student services personnel, principals and other staff, with the assistance of parents/guardians, in the value and utility of contributions of parents/guardians and in how to reach out to, communicate with and work

- with parents/guardians as equal partners, implement and coordinate parent/guardian programs, and build ties between parents/guardians and the school.
- 9. Coordination with other Parent Involvement Programs. Training is available through the migrant office and will be made available to parents/guardians at Island Union Elementary School.
- 10. Communications in the Language of Parents. Written communications intended for parents are available in English and Spanish. If parents need to receive information in another language or format, parents will contact the school office.
- 11. Participation of parents of special needs students. Parent participation in Title I input, training, and meetings will include parents/guardians with limited English proficiency, parents/guardians with disabilities and parents/guardians of migratory children.
- 12. Title I support for Parent Involvement activities. Title I funds will be provided by as approved in the Title I or Schoolwide Program budget.
